Directions to Coppin State University

From the North

- Take I-95 South to Baltimore Beltway I-695 West
- Follow I-695 West to Exit 23 (Rt. 83 South)
- Take I-83 South to Exit 6 (North Avenue)
- Turn right onto North Avenue to 2500 W. North Ave
- Turn right at Loop Rd entrance directly after you go under the pedestrian walkway bridge crossing North Ave.
- Follow Loop Rd to parking Lot F on your right (you will pass parking lots B and Lot D).

From the South

- Take I-95 North to Baltimore Exit 50 (North Caton Ave.)
- Please note that Caton Ave. turns into Hilton St, then Hilton Pkwy, then Hilton St again
- Turn right on Gwynns Falls Pkwy from Hilton St.
- Follow for a few blocks to 2523 Gwynns Falls Pkwy
- Turn right at the CSU Gwynns Falls Pkwy entrance (you are on Loop Rd)
- Follow Loop Road to parking Lot G (next to tennis courts) & Lot F on your left

From the East

- Take US Rt 40 West (Pulaski Hwy) to North Fulton St
- Pulaski Hwy turns into Fayette St
- Turn right on North Fulton St and follow to North Avenue
- Turn left onto North Avenue to 2500 W. North Ave
- Turn right at Loop Rd entrance directly after you go under the pedestrian walkway bridge crossing North Ave
- Follow Loop Rd to parking Lot F on your right (you will pass parking lots B and Lot D).

From the West

- Take I-70 East to I-695 South and follow to Exit 15 (Rt 40 East)
- From Rt 40, turn right onto Hilton Parkway-Hilton Parkway eventually turns into Hilton St.
- Turn right onto Gwynns Falls Pkwy
- Follow for a few blocks to 2523 Gwynns Falls Pkwy
- Turn right at the Gwynns Falls Pkwy entrance (you are on Loop Rd)
- Follow Loop Road to parking Lot G (next to tennis courts) & Lot F on your left
